**CONGRESS RESOLUTION**  
**Executive Committee of the World Federation of  
Vietnam Vocotruyen Term II – 2023**

According to the Regulations of the World Federation of Vietnam Vocotruyen (WFV);

According to the Resolution of the Congress of the World Federation of Vietnam Vocotruyen Term II (2022-2027);

On January 30, 2023, the Executive Committee of the World Federation of Vietnam Vocotruyen held the first meeting in Hanoi with 47/50 participants (offline and online): President, Vice Presidents, members of the Standing Committee. After discussing and agreeing by voting 47/47 to agree, the Standing Committee of the World Federation of Vietnam Vocotruyen,

**DECISION:**

**Article 1.** Approval of the report on activities in 2022, directions and tasks for the year 2023-2024 of the World Federation of Vietnam Traditional Martial Arts.

**Article 2.** The Executive Committee highly agreed to amend the Federation's Regulations as follows:

1. Change the WFV head office, establish 02 head offices: 01 in the territory of Vietnam and 01 in the city of Marseille, France (*Clause 2, Article 3, Chapter I*).

2. Change in personnel of the General Assembly. The new personnel will include: WFV President, Vice Presidents, Secretary General and Presidents of the Regional Federations (*additional 01 Clause to Article 9, Chapter III*).

**Article 3.** Agree on admitting 35 new members to WFV (*attached list*).

**Article 4.** Unanimously elect 13 additional members of the Executive Committee: 8 foreign members and 5 Vietnamese (*list attached*). The Executive Committee agreed for Mr. Mai Hac Long to resign as a member of the Executive Committee according to his personal wishes.

**Article 5.** Establishment of WFV functional boards. In particular, the Technical Board elected the International Grand Master Truong Van Bao and the International Grand Master Nguyen Cong Tot as co-heads of the Technical Board.

**Article 6.** Change of personnel of the International Masters Council and The International Grade Review Council. Unification and consolidation led by the President Nguyen Ba Manh.



**Article 7.** The Executive Committee of WFVV agreed to continue to confer the awards of high-ranking Masters and Grand Masters of all levels.

**Article 8.** Unified establishment of the Northern Martial Arts Medical Center./.

The resolution was approved by 47/47 (100%) members attending the meeting./.
